

## **REGULATION FOR AFFILIATION and REAFFILIATION OF FAIRS – 2025**

### **ACCREDITATION OF PROJECTS IN HIGH SCHOOL AND/OR TECHNICAL-PROFESSIONAL EDUCATION OF MIDDLE LEVEL, ELEMENTARY EDUCATION AND EARLY CHILDHOOD EDUCATION**

All the scientific and/or technological research fairs whose projects and students meet all criteria for participation in MOSTRATEC-LIBERATO, described below, may forward the request for affiliation or re-affiliation to MOSTRATEC-LIBERATO, within the period established in this regulation. The application for affiliation/re-affiliation must be completed annually.

#### **1. AFFILIATION CRITERIA**

- a) number of vacancies available for the current edition of MOSTRATEC-LIBERATO;
- b) submission of the Affiliation Form meeting deadlines;
- c) extent of the affiliated fair (scholar, regional, state, national);
- d) minimum of 30 (thirty) high school and/or technical-professional education of middle level projects;
- e) the accredited research project must meet MOSTRATEC-LIBERATO requirements (see item 5 of this regulation);
- f) **effective participation in MOSTRATEC-LIBERATO in the previous year**, in case of affiliation renewal;
- g) second edition of the fair, at least;
- h) to participate in MOSTRATEC-LIBERATO 2025, the affiliated fair **must be held by 27/09/2025**. Fairs held after that date must accredit projects for MOSTRATEC-LIBERATO 2026.

#### **2. INSTRUCTIONS FOR THE AFFILIATION REQUEST**

The person in charge of the fair interested in accrediting to participate in MOSTRATEC-LIBERATO must send the request **from May 1<sup>st</sup> to May 31<sup>st</sup>** through the online form available on Mostratec Digital website <https://digital.mostratec.com.br/>.

Fairs that have already made some affiliation in the Mostratec Digital system, just log in to access the Fair Panel at <https://digital.mostratec.com.br/login> using the email and access password and request renewal membership for this year by filling in the form again. **If the person in charge does not remember or does not know the access email, contact us so that we can find the correct information – do not register again!**

**Vacancies should be requested separately for each level of education and for each category of elementary school, as follows:**

- Early Childhood Education: Children aged 4 to 6 (preschool)
- Elementary School:
  - \* Category 1: 1st to 3rd grade
  - \* Category 2: 4th to 6th grade

\* Category 3: 7th to 9th grade

\* Category 4: Youth and Adult Education - EJA (all years)

- High School and/or Technical Professional Education at the High School Level

Affiliation or renewal requests are evaluated annually by the MOSTRATEC-LIBERATO Executive Committee. All the fields must be completed. ### 3. GUIDELINES AFTER THE FAIR IS CONFIRMED AS AFFILIATED

The affiliated fairs will receive an email informing them that the affiliation has been approved. Then, must access the Fair Panel, logging in at <https://digital.mostratec.com.br/login>. There it will be possible to consult the number of vacancies granted and approve the registration of projects that it has accredited after they have registered.

Affiliated fairs will have 03 days after the end of their fairs to inform, by email ([mostratec@liberato.com.br](mailto:mostratec@liberato.com.br)), data related to the project(s) accredited to MOSTRATEC-LIBERATO 2025: **level of education, project title, area, name of all the members and their contact details** (e-mail and telephone/WhatsApp).

Affiliated fairs will have their data published on MOSTRATEC-LIBERATO website, Edition 2025/ Affiliated Fairs 2025 (<https://mostratec.liberato.com.br/en/affiliated-fairs/>).

The affiliated fair is responsible for monitoring the registration process of the project(s) accredited to MOSTRATEC-LIBERATO and for guaranteeing its participation, informing MOSTRATEC-LIBERATO, in a timely manner, of any changes that may occur. Cases of inability to participate must be reported to the MOSTRATEC-LIBERATO Secretariat as soon as possible. In case of replacement of projects (within the registration period), the person in charge of the affiliated fair must contact the MOSTRATEC-LIBERATO Secretariat for guidance.

In cases where there is no communication of the absence, the participation of the affiliated fair in the following year's edition of MOSTRATEC-LIBERATO will be reassessed by the Organizing Committee and may be conditioned to the existence of vacancies.

### 4. PROCEDURES TO REGISTER THE PROJECTS

- a) read carefully the guidelines to register on <https://mostratec.liberato.com.br/en/rules-of-mostratec/>;
- b) access Mostratec Digital Platform (during the registration period, according to the schedule available on the website <https://mostratec.liberato.com.br/en/schedule-affiliated-fair/>), pre-register, confirm the link received by email and log in to the system;
- c) register the project data in the system and upload the requested documents and forms;
- d) submit the application (an email will be sent confirming the completion of the application).

At any time, the SRC - Scientific Review Committee of MOSTRATEG-LIBERATO – may request additional information and/or forms, which must be sent by email, following the directions given, and according to the deadline given by the reviewer who requested them.

## 5. PARTICIPATION CRITERIA

### The student must:

- a) be enrolled in an educational institution, at the level corresponding to the registered project (Early Childhood Education, Elementary Education, Youth and Adult Education, High School and/or Technical-Professional Education of Middle Level) at the time of receiving the credential;
- b) be accompanied by an adult, if minor 18 (the mentor can be the guardian);
- d) participate with only 01 (one) project;
- e) register the project within the deadlines established by MOSTRATEG-LIBERATO.

### The project must:

- a) have a mentor (older than 21 and with a higher education degree). The project can have up to two co-mentors;
- b) be conducted by up to 3 (three) students enrolled in high school or in a technical-professional education course of middle level, or in Elementary Education categories 2, 3 or 4 (all student authors of the project must be registered, even if they do not participate in person at MOSTRATEG-LIBERATO);

**ATTENTION:** It is the responsibility of the affiliated fair to be aware that the **AUTHORSHIP AND DEVELOPMENT** of the High School and/or Technical Education project indicated by it is of a **maximum of 3 students**. If it is found that there were more authors not mentioned, the project will be disqualified from MOSTRATEG-LIBERATO and the affiliated fair will be notified. - c) be conducted by up to 4 (four) students enrolled in Elementary Education category 1 or Early Childhood Education;
- d) present a continuous research study of maximum 12 (twelve) months developed in the previous year of the current edition;
- e) be **authored** by the student(s) of the level of education informed at the time of registration and be conducted according to MOSTRATEG-LIBERATO's scientific and ethical research rules. It is the exclusive responsibility of the participants the authorship, category or area of research chosen and the veracity of the information provided in the registration form.

Projects classified by an affiliated fair must meet the criteria established above, otherwise they will be disqualified regardless of the selection made by the affiliated fair. In addition, they must follow all the requests that MOSTRATEG-LIBERATO SRC requires, otherwise they may be disqualified.

The Organizing Committee is sovereign in decisions on all matters mentioned in this regulation. The missing cases will be solved by the Organizing Committee of MOSTRATEC-LIBERATO and the Executive Direction of Liberato School.
